

PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

**Subject:** Regarding grant of affiliation for B.Sc. (Nursing) Course to Chinmaya Institute of Nursing, Bangalore.

**Read:** Letter No.ACA/F/NS-005/2009-10 dated 2.12.2008.

**PROPOSAL**

In the above cited letter, the Rajiv Gandhi University of Health Sciences, Bangalore has recommended affiliation for B.Sc. (Nursing) Course to be newly started in the Chinmaya Institute of Nursing, Bangalore from the year 2009-10 with an intake limit of 40 seats while submitting the application made under section 45(2) of the Rajiv Gandhi University of Health Sciences Act, 1994 along with the report of the Local Inquiry Committee and decisions of the Academic Council and the Syndicate. It has not recommended the starting of M.Sc. (Psychiatry) Course.

Having examined the matter in detail along with all connected records, Government have decided to grant affiliation to the Chinmaya Institute of Nursing, Bangalore to start newly the B.Sc. (Nursing) course from the year 2009-10 with an intake limit of 40 seats and has issued these orders.

Government Order No.AKuKa 09 MPS-2009, Bangalore dated 25.05.2009

In exercise of the powers given under section 45(5) of the Rajiv Gandhi University of Health Sciences Act, 1994 the Government recommends grant of affiliation to the Chinmaya Institute of Nursing, Bangalore to start newly the B.Sc. (Nursing) Course from the year 2009-10 with an intake limit of 40 seats, subject to following terms and conditions.

Terms and Conditions

- (1) The Chinmaya Institute of Nursing shall surrender 20% of the seats for allotment by Government.
- (2) Grant of affiliation for the above course shall be obtained from the Rajiv Gandhi University of Health Sciences.
- (3) Grant of recognition by the Indian Nursing Council under section 13 of the Indian Nursing Council Act, 1947 shall be obtained and the Regulations prescribed by the Indian Nursing Council shall be strictly adhered to. Basic facilities prescribed by the Rajiv Gandhi University of Health Sciences, Karnataka State Nursing Council and Indian Nursing Council shall be provided.
- (4) Admission upto the prescribed intake shall be made only after approval of the Indian Nursing Council Act, 1947 and on no account shall admit more students than the permitted intake. Any violation will attract criminal prosecution under Karnataka Unrecognised and Unaffiliated Educational Institutions (Prohibition of Admission of Students) Act, 1991.



- (5) Guidelines and Orders issued from time to time by the Indian Nursing Council, Karnataka State Nursing Council and the State Government shall be followed.
- (6) In accordance with the guidelines of the Indian Nursing Council, the College should have its own hospital within 5 years, failing which, the affiliation granted to the College will be withdrawn.
- (7) Admission of students shall be made in accordance with Karnataka Nursing, Pharmacy and Physiotherapy Courses (Selection of candidates for admission) Rules, 2003 and in accordance with ratio prescribed between government quota and management quota in M.Sc. (Nursing) M.P.T. and M.Pharm Course.
- (8) No grant-in aid or financial help will be extended by the Government to the above said College. The College is subject to the condition that it shall be a Permanently Unaided College.
- (9) Violation of any of the above conditions by the College will result in withdrawal of affiliation under section 18 of the Rajiv Gandhi University of Health Sciences, 1994.
